WHEREAS, The Government Records Access Management Act requires that Service Areas establish a Records Manager; and,


WHEREAS, the said Act allows Service Areas to impose reasonable fees for copies and for other services provided to those who seek public records.

NOW THEREFORE, be it resolved by the Salt Lake County Service Area #3 Board of Trustees as follows:

Section 1. Records Manager. The Salt Lake County Service Area #3 clerk is hereby established as the Records Manager for Salt Lake County Service Area #3.

Section 2. Fees. Fees for the production and copying of records shall be in accordance with the Government Records Access Management Act and shall be established by resolution.

A RESOLUTION
ADOPTING A FEE SCHEDULE FOR RECORDS REQUESTS PURSUANT TO THE
GOVERNMENT RECORDS ACCESS MANAGEMENT ACT

WHEREAS, The Government Records Access Management Act, ("GRAMA") allows the public to request various public records of Salt Lake County Service Area #3; and

WHEREAS, Salt Lake County Service Area #3 is entitled to be compensated for time and costs incurred in the production of said documents; and


WHEREAS, applicable state statutes allow Salt Lake County Service Area #3 to impose reasonable fees;

NOW THEREFORE, be it resolved by the Salt Lake County Service Area #3 Board of Trustees as follows:

GRAMA FEES

- (1). Compiling records in a form other than that maintained by Salt Lake County Service Area #3: Actual cost and expense for employee time (\$30.00 per hour per request for time exceeding 15 minutes per request).
- (2). Supplies and equipment including database material or other media: Actual cost to Salt Lake County Service Area #3.
- (3). Copy of record: \$0.20 per page.
- (4). Postage, including shipping materials and method of shipment: Actual cost to Salt Lake County Service Area #3.
