I forward to you my original Request which was furnished on September 10, 2018 to certain certified Records Officers of certain governmental entities (CRO) and reasonably described that I wanted to access and inspect certain opinions, interpretations and correspondence regarding penal bonds executed and filed by certain persons elected or appointed as certain officers of such governmental entities.

I also forward to you my original Appeal which was furnished on September 25, 2018 to certain "Chief Administrative Officers" (CAO) of certain governmental entities with respect to the constructive denials established by such CRO.
