Dear Gina,

I forward to you my original Amended Request of August 9, 2018 which was furnished to certain "Authorized Records Officer" (ARO) of certain governmental entities and described that I wanted to access and inspect certain public official penal bonds executed and filed by certain persons elected and appointed as certain officers of such governmental entities, certain constitutional oaths of office subscribed and filed by such persons and certain records with respect to the Utah Local Governments Trust (ULGT).

I also forward to you my original Appeal which was furnished on August 24, 2018 to certain "Chief Administrative Officer" (COA) of certain governmental entities with respect to the above described bonds, oaths and ULGT records.

With respect to Cache County Utah (CCU), the State Record Committee has scheduled a hearing with respect the ARO and the COA of CCU constructively denying my inspection of certain public official penal bonds executed and filed by certain persons elected as certain officers of CCU.

CCU has not responded to my Request or admitted in any way that certain records with respect to the ULGT were never created or were lost, transferred, damaged or destroyed. Both the ARO and the CAO of CCU of CCU are constructively denying my inspection of such certain ULGT records.

With respect to the City of Hyrum, Utah (HCU), I was only provided various billing notices, endorsements, crime policy declarations, crime general provisions, crime policy conditions, public employee dishonesty coverage form, invoice summary statements, continuation certificates, riders, power of attorney. HCU has not responded to my Request or admitted in any way that the actual public official penal bonds executed and filed by certain persons elected or appointed as certain officers of HCU or that certain records with respect to the ULGT were never created or were lost, transferred, damaged or destroyed. Both the ARO and the CAO of HCU are constructively denying my inspection of such certain bonds and ULGT records.

With respect to the City of North Logan, Utah (NLU), I was directed by its ARO to inspect the records described above at the physical office of NLU. I was provided a file that only contained certain constitutional oaths of office and a document issued by the Leavitt Group of Northern Utah that just referred to bonds. NLU has not responded to my Request or admitted in any way that the actual public official penal bonds executed and filed by certain persons elected as certain officers of NLU or that certain records with respect to the ULGT were never created or were lost, transferred, damaged or destroyed. Both the ARO and the CAO of NLU are constructively denying my inspection of such certain bonds and ULGT records.

With respect to the City of Hyde Park, Utah (HPU), I received in the mail only a certain "Public Official Name Schedule Bond" and a "Fidelity Bond". However, the schedules identifying the officers or employees and the penal sums which are covered by such bonds were not provided to me. HPU has not responded to my Request or admitted in any way that such schedules, certain constitutional oaths of office subscribed and filed by certain person elected or appointed as

certain officers of HPU and certain records with respect to the ULGT were never created or were lost, transferred, damaged or destroyed. Both the ARO and the CAO of HPU are constructively denying my inspection of such certain schedules, oaths and ULGT records.

With respect to the following governmental entities, both their ARO and the CAO are constructively denying my inspection of certain public official penal bonds executed and filed by certain persons elected or appointed as certain officers of such entities, certain constitutional oaths of office subscribed and filed by such persons and certain records with respect to the ULGT:

- (1) City of Smithfield, Utah,
- (2) City of Richmond, Utah,
- (3) City of River Heights, Utah,
- (4) City of Providence, Utah,
- (5) City of Nibley, Utah,
- (6) City of Millville, Utah,
- (7) City of Wellsville, Utah,
- and
- (8) City of Tremonton, Utah.

Not one of the ARO or the CAO of the above described governmental entities has responded to my Request or admitted in any way that certain elected and/or appointed officers of such governmental entities never executed and filed or lost, transferred, damaged or destroyed their respective public official penal bonds.

Not one of the ARO or the CAO of the above described governmental entities has responded to my Request or admitted in any way that certain elected and/or appointed officers of such governmental entities never subscribed and filed or lost, transferred, damaged or destroyed their respective constitutional oaths.

Not one of the ARO or the CAO of the above described governmental entities has responded to my Request or admitted in any way that certain records with respect to the ULGT were never created or were lost, transferred, damaged or destroyed.

I hereby appeal the constructive denials which I've described above.
