1. This matter is remanded to the Utah State Records Committee (the "SRC") to clarify its March 28, 2022, Decision and Order. Specifically, the SRC shall explain in detail any consideration of the reasonableness of the County's decision to deny the fee waiver and enter

findings of fact on reasonableness consistent with the directive set forth in *Salt Lake City Corp. v. Jordan River Restoration Network*, 2018 UT 62.

2. The SRC shall issue an amended Decision and Order within seventy three (73) days of the date of this Order.
